Louisiana 2-1-1 is a statewide collaboration between 5 licensed non-profit 2-1-1 providers, United Way funders, other funders, public partners serving on the LA 2-1-1 Coordinating Council and the Louisiana Association of United Ways (LAUW). LAUW serves as a statewide coordinator of this initiative. Together, we work to increase the capacity of Louisiana 2-1-1. During this fiscal year, more than 210,000 citizens were helped through Louisiana 2-1-1 information and referral services. Some 2-1-1 service providers are compensated by contract payments provided by Louisiana Association of United Ways.

As per Act 501 of the 2012 LA Legislative Session (LAC 4:III Chapter 11), LAUW serves as the Principal Coordinating Fundraising Organization (PCFO) for the Louisiana Statewide Combined Charitable Campaign (LA SCCC). Launching in September 2014, this annual campaign will reach more than 35,000 state employees and will provide employees options to give through payroll deduction. Approved health and human service charities are eligible to receive these designated donations. LAUW works closely with the Office of Uniform Payroll in the LA Division of Administration to carry out this campaign. This fiscal year was a preparation year, including the acceptance of first-year charity applications.

Authorized by law, LAUW promotes giving to Louisiana 2-1-1 through the LAUW/LA 2-1-1 tax checkoff box on state returns. Funds received by state tax payers are used by LAUW to build the capacity of LA 2-1-1 services, including technical services needed to advance efforts and resources for 2-1-1 providers to support operations.
