Donations of \$200,641 were received by Concordia Lutheran Ministries Foundation on behalf of our affiliate organizations.

These expenses are donations and grants given through our Angel Tear program. These expenses also include travel costs related to the oversight of such programs. Donations of \$1,072 were received to the Angel Tear Ministries Fund.
