Between July 2013 and June 2014, NightLight in Bangkok provided alternative employment, vocational training, spiritual development, meals, health care, and life-skills training to an average of 42 women who were exiting or at risk of exploitation in the sex industry. As part of their support, NightLight provided childcare for an average of 16 children under the age of 5 and tuition scholarship to 34 children. NightLight makes contact with several hundred women in prostitution and trafficking each year and offers assistance and intervention. 110 internationally trafficked victims were assisted and 26 were repatriated during the fiscal year. Additionally, 17 children of these women also received assistance. The shelter NightLight set up for victims of trafficking and sexual exploitation is now fully operational and houses many of the internationally trafficked women we assist. NightLight also addresses the sex-industry through activities in our outreach center in one of the major red-light districts of Bangkok. The coffee shop on the bottom floor of the outreach center was completed this fiscal year and is now fully operational. CityLight Cafe has been key in starting to address the demand side of the sex industry by giving us an opportunity to connect with the male tourists as well as the broader community of those affected by the sex industry. The outreach center now offers weekly English classes and quarterly medical clinics. NightLight also does prevention work in the Northeast of Thailand to address the supply of young women into the sex trade. On the streets of Bangkok, NightLight reaches out to and provides assistance to the children who beg, vend, and are at high risk of trafficking. NightLight actively does awareness-raising through trainings, speeches, and media that reaches a global audience. NightLight Bangkok received almost 500 visitors this year who heard about the work of NightLight and learned about how to engage with the problem. NightLight partners with many other NGOs and government organizations to combat trafficking through investigation, intervention, assistance, shelter, and repatriation.

In the 2013/14 fiscal year, NightLight's office in Atlanta moved into an outreach center in an at-risk neighborhood and spent a great deal of time strategizing, training, and fundraising for future programs that will be held in that facility. NightLight continued regular outreaches, and ministered to hundreds of individuals in Atlanta's sex industry.

In the 2013/14 fiscal year NightLight established a new office in Branson, Missouri. By June of 2014 NightLight Branson was consistently ministering to approximately 100 women working in the strip clubs every month. In addition, over a dozen women were positively impacted by NightLight Branson's restoration program, a mentorship program that encourages the development of healthy relationships outside of the "club" environment.
