Pride Academy Charter School commenced implementation in the 2008-2009 school year and has just completed its fifth year of operation. The school's charter authorized a maximum enrollment of 240 students in Grades 5-8. During the first charter renewal, Pride Academy sought and obtained approval for increased enrollment to 264 students. The enrollment at the beginning of the school year was 264 students. At the end of the year the enrollment was 264 students. There are three classes each of Grades 5, 6, 7, and 8, with class sizes of 22 students per class. As of July 31, 2014, there were 241 students on the waiting list. During the 2013-2014 school year, the Charter School's Administrative team continued to lead the growth and strengthening of the school in the Sixth year of operation. Of the many accomplishments of the charter school was the continued development and implementation of an elective and after school program that offers a wide range of athletic, academic, and culturally enriching activities and experiences that included Student Council, yearbook, cheerleading, basketball, soccer, flag football, African Dancing, MVP male empowerment, cooking, chorus, multicultural clubs and book clubs. In addition, the Charter School supported the development of a facility expansion that will result in improvements to classroom and common area spaces, and will enhance the overall educational program.

WHISTLEBLOWER POLICY	PRIDE ACADEMY CHARTER SCHOOL HAS A WRITTEN WHISTLEBLOWER POLICY WHICH PROHIBITS DISCRIMINATION OR RETALIATION AGAINST ANY SCHOOL EMPLOYEE WHO (1) DISCLOSES OR THREATENS TO DISCLOSE TO A SUPERVISOR OR APPROPRIATE ENTITY A POLICY OR PRACTICE WHICH THE EMPLOYEE REASONABLY BELIEVES IS IN VIOLATION OF LAW, (2) PROVIDES INFORMATION TO ANY PUBLIC BODY CONDUCTING AN INVESTIGATION OR INQUIRY INTO ANY ALLEGED VIOLATION OF LAW, OR (3) OBJECTS TO, OR REFUSES TO PARTICIPATE IN ANY ACTIVITY, POLICY OR PRACTICE WHICH THE EMPLOYEE REASONABLY BELIEVES IS IN VIOLATION OF LAW, IS FRAUDULENT OR CRIMINAL, OR IS INCOMPATIBLE WITH PUBLIC HEALTH OR SAFETY
