Care Coordination - The function of care coordination is to assure the meaningful connection of clients to donated resources Care Coordinators are responsible for determining eligibility of clients, orienting them to the program, assigning referrals to volunteer providers, providing reminder calls, serving as a point of contact for any barriers that come up regarding ability to connect to care

Pharmacy - A core piece of health care is access to needed medication to manage chronic conditions and cure episodic conditions Pharmacy Bridge Provides patients with basic medications for a \$4 co-pay In addition, the medication is available directly through the pharmacy benefit We also use volunteers to process medication assistance applications for patients to receive brand name medications at no cost The contracted rate for medications made available to us saves over 60% off of the average wholesale price of medication

Even with the implementation of the Affordable Care Act, there is still a need for our classic work of connecting people to donated health care Our volunteer network has only experienced minimal reduction, which allows us to continue this programming During this fiscal year we served more than 3,000 people through our classic program Additionally, we have built on our competencies to add additional strategies Specifically, Project Access NOW has established the Community Premium Assistance Program that pays for insurance premiums for low-income individuals who make a little too much money to qualify for the Oregon Health Plan (Medicaid) Not only do we pay for the premium, we also have secured participation from our volunteer partners to write off the out of pocket costs for our participants, which are often more of a barrier than actual premium payments 150 people were enrolled in this program during this fiscal year Project Access NOW was also active in regards to enrollment assistance in general during the roll out period of the Affordable Care Act in Oregon The organization provided a support to individuals and organizations to assure that as many people as possible could enroll in health insurance coverage of any type Nearly all of our clients that qualified for Oregon Health Plan were enrolled during the initial open enrollment session Additionally, we supported the members of the Oregon Medical Insurance Pool (OMIP) in their transition to different insurance coverage Our staff made over 25,000 phone calls and provided individual navigation services to over 400 OMIP membersProgram development work in other areas, such as supporting the connection of clients to social service programming and building community-wide solutions to address tenants of the Affordable Care Act, is ongoing
