Cultivated by a highly esteemed university environment and committed faculty, GCU offers an innovative liberal arts curriculum that promotes scholarship, service, leadership, and personal development. Driven by the Sisters of Mercy's core values of respect, integrity, service, justice, and compassion, Georgian Court has a commitment to creating world citizens and helping students use their unique strengths to find purpose that place where talent and passion, purpose and intellect, intersect.

	Georgian Court University serves about 2,300 students in 30 undergraduate and 10 distinctive graduate programs. Students are enrolled through the GCU School of Business, School of Education and the School of Arts and Sciences, as well as the GCU-Meridian Health School of Nursing. The university also offers online degrees and specialty certificates in such fields as holistic health, homeland security, and graduate education. Georgian Court, located in historic Lakewood, N.J., is dedicated to the personal and professional success of its students. The university has historic roots as a women's college, and served men in evening and graduate courses---usually part-time---until September 2012. Beginning that year, men were eligible to enroll fulltime in any course as the university prepared to become fully coeducational by Fall 2013. Since then, GCU has successfully transitioned to a fully coeducational model with men participating in sports, student government, campus leadership, and residence life. GCU provides all of its students values-based liberal arts education that enhances their marketability across various disciplines and emphasizes purposeful leadership that enables alumni to excel in their careers. GCU graduates contribute to the greater good locally, nationally, and throughout the world. GCUs consistent 13:1 student-faculty ratio facilitates unique learning relationships and fosters valuable research opportunities between professors and their students. Small classes with approachable faculty are especially helpful for adult learners (28% percent of GCU students are non-traditional learners older than 22), many of whom are juggling university studies with busy schedules, job and family obligations. In recent years, GCU has added new areas of study that reflect employment trends. In May 2014 the university graduated its third class of nurses to earn their B.S.N. degrees through the GCU-Meridian Health School of Nursing. The university also saw accolades in education (reaccreditation by the Council for the Accreditation of Educator Preparation-CAEP) business (the Accreditation Council for Business Schools and Programs), and in international learning efforts (Collaborative Online International Learning-COIL) with universities outside of the U.S. Overall, GCU gives students an exceptional learning environment where they gain valuable experience in their disciplines before graduation. Students often work alongside faculty mentors in social work, biochemistry, business, autism studies, early childhood education, learning disabilities consulting, and school psychology. Those studying criminal justice, dance, exercise science, and other fields are equally as involved. Georgian Court University prepares students for life beyond the campus gates. By senior year, more than 75 percent of GCU students say Georgian Court challenges them to do their best work, and among freshmen, upward of 59 percent of students report being involved in high-impact practices such as service learning or Service, one of GCUs Mercy core values, is embedded in experiences throughout their college years, as evidenced by the 6,000+ volunteer hours GCU students invested in neighboring communities during the 2013-14 academic year. Additional partnerships and programs at locations throughout the region extend the reach and mission of Georgian Court University. For example, in February 2014, GCU announced its new Guaranteed Tuition Initiative with neighboring Brookdale Community College, GCUs largest two-year college feeder. The program offers high-achieving community college graduates additional incentives to complete their bachelors degree at Georgian Court. In 2014, GCU launched International Collaboration Center, a high-tech classroom created to connect GCU students and faculty with their peers in other countries through research, course presentations, collaborative projects and virtual face-to-face meetings. The ICC is part of GCUs larger Global Transformation Initiative. Internationally, GCU partners with John Cabot University in Rome, the University of Sterling in Scotland, St. Augustine University in Tanzania, Universidad Catolica de El Salvador, and other institutions. Last year, 41 GCU students took advantage of education abroad opportunities in Europe, Africa and South America, many of their experiences were funded by global education scholarships, making education abroad opportunities more accessible for all students. Professional conferences sponsored on the Georgian Court campus by university faculty and their departments also contribute to GCUs growing reputation as a leader in such fields as applied behavior analysis, clinical mental health counseling, and holistic health. Beyond undergraduate and graduate education, Georgian Court extends educational opportunities to senior adults through the McAuley Institute for Lifelong Learning (MILL). The program, launched in 2009, has grown from two pilot courses to more than 50 classes that cover subjects ranging from Twitter 101, spirituality and creative writing, to the history of protest music in the United States and healthy lifestyle cooking and eating. Since its founding, MILL has registered more than 500 seniors, ages 50 and older, for non-credit, college-level courses taught by faculty. About 99 percent of GCU's full-time first-year students receive aid with an average financial aid package of \$26,026. About 45 percent of all full-time freshmen receive Pell grants (federal aid). In addition, 45 percent of entering freshmen were first-generation college students. For prospective and current Georgian Court students, paying for college is the single biggest roadblock to pursuing a degree. However, with adequate financial support, Georgian Court students succeed in the classroom. Georgian Court is not a typical institution because its high volume of commuter, graduate students, non-traditional students and Commiversity students (who take courses at an off-campus site) all contribute to school pride in ways that a university with a larger body of resident students is more apt to have.

	STUDENT-ATHLETES AT GCU - As a member of the Central Athletic Collegiate Conference, Georgian Court University fields 186 athletes in NCAA Division II sports, including basketball, cross country, lacrosse, soccer, softball, volleyball, tennis, and both indoor and outdoor track & field. The GCU athletics program is distinguished by its commitment to building well-rounded athletes who achieve on the field and in the classroom. In keeping with their peers nationally, GCU student-athletes cultivate leadership skills in their individual sports and in their classroom and community involvement. The teams are very active in the community, as well, and have raised thousands of dollars for the Susan B. Komen Walk for the Cure, cancer research, Make-a-Wish Foundation, and National Girls and Women in Sports Day.
