Residential Services - The Agency operates sixteen homes, including five new homes opened in the current year with one additional home that is in development A new day program was also added in the current year These programs provide 24 hour support and supervision for men and women with intellectual and developmental disabilities, and specialize in services for people who are also deaf and/or blind People with behavioral challenges, autism and specialized medical needs also receive community based support through this program Services provided include but are not limited to medical coordination and medication administration, meal planning and preparation, transportation, recreation and socialization, personal finance management including coordination of entitlements, and behavioral support and intervention Program staff receives professional training in all areas of personal care, and health and safety Support is focused on the individual so they may participate in, enjoy and have access to the activities of daily living within their own scope of preferences and level of independence
