The mission of Westerly Area Rest Meals (WARM), Inc. is to provide a continuum of care and service to the homeless and needy by providing safe, affordable housing and assuring supportive services.

Shelter Program: The emergency shelter program for single individuals housed 166 unduplicated individuals during this fiscal year for a total of 7,032 bed nights. Of those individuals, 48 were able to move into permanent housing without the assistance of a subsidy, an additional 22 clients moved in with family or friends on a permanent basis, 25 moved into transitional housing within WARM's programs or other resources, 22 were short term stayers (less than one week), 30 did not complete the program or were asked to leave and 19 remained in the shelter. Of those individuals that left the program, 118 were able to secure full or part time employment.

4b (Code) (Expenses \$ **224,104** including grants of \$) (Revenue \$ **55,672**)

Harvest Homes: In fiscal year 2014, the Harvest Homes program provided housing for 15 homeless families consisting of 23 Adults and 27 children as well as an additional 21 individuals. Harvest Homes program provided 11,864 bed nights to those individuals. Without the resources of Harvest Homes, these families and individuals may have been homeless and in a shelter. Of the 5 families who completed the program, 4 went on to permanent housing and one returned to a shelter. Of the 11 individuals who completed the program, 8 found permanent housing without a subsidy, 2 found section 8 housing and one left the program returning to another state. All of these families and individuals left having increased income, making housing more affordable.

Outreach: With a generous grant from the United Way of Rhode Island, the WARM Center was able to provide financial assistance to 277 households. This consisted of 454 adults and 314 children. In total, WARM provided more than \$50,000 in assistance to these households in the form of financial assistance for rent, utilities, hotel and motel vouchers. In most cases, this assistance prevented these families and individuals from entering into homelessness.
