	ADTI Housing Corp is a subsidiary of Alternatives, Inc , a NJ Not-For-Profit Corporation, dedicated to the creation of affordable housing for Alternatives, Inc 's consumers with special needs as well as low/moderate income people from the general public The staff of housing development and financial professionals specializes in the creation of affordable housing units for those most in need of safe and decent homes During Fiscal Year 2014, ADTI Housing Corp provided property and facilities management services to over 150 agency-owned special needs and affordable housing units throughout Central New Jersey In addition, ADTI acted as the authorized agent for over 80 properties leased by Alternatives, Inc , the parent company, to provide housing to individuals with special needs ADTI Housing Corp was approved as a Qualified Housing Developer by New Jersey Housing Mortgage and Finance Agency (HMFA) for the Special Needs Housing Partnership Loan Program (SNHPLP), and it experienced an increase in capital through grant writing activities for the creation and maintenance of agency-owned projects ADTI secured \$287,620 in HOME Investment Partnership funds to expand the Franklin House Transitional Housing Program, in Somerset County, to provide transitional housing to formerly homeless families
