Letter from the President of the Northern NJ Community Foundation

To I R S Non-profit Representative

The Northern New Jersey Community Foundation (NNJCF), a 501(c)3 public charity, is currently embarked on a comprehensive, three-year restructuring plan to include building the board, broadening its donor base, and hiring an executive director. We remain convinced, since our incorporation in 1998, that citizens in Northern New Jersey can and have benefitted from the public services of the NNJCF. We have succeeded in our mission "to improve the lives of Northern New Jersey residents through the Foundation's work in education, public health, and civic engagement." We are fulfilling the roles of community foundations: making grants that address current and emerging needs in the region, providing donor services that present residents with philanthropic opportunities to serve their communities, and in convening citizens, institutions, and agents of local governments to discuss and resolve problems of mutual concern.

We document below specific successes in these areas. While we have not yet achieved the exceptional results that we anticipate, we have taken steps to assure that we will. The Foundation has engaged a preeminent consulting group, "The Support Center – Partnership in Philanthropy," to assist in our reorganization. A letter from this group, is attached.

The Foundation is, of course, responsible for not reaching its full potential. It must be said, however, that the financial crisis of the last six years has made small non-profits' growth problematic. In addition, our efforts have been hampered by New Jersey's being split into 565 autonomous municipalities. This division has minimized the benefits of our collaborative programs, which when fully implemented will effectively combat this insularity. By doing so, the Foundation will enable the kinds of cooperative shared services that can lower the costs of living and doing business in our state. This movement toward regional collaboration is ably assisted by our representative board. Please see attached biographical information.

Our confidence in our capability to contribute significantly to the region's viability is shared by administrators at the local, county, and state levels as outlined below. Here is a "state level" statement by 37 District Assemblywoman, Valerie Huttie.

"Our quality of life depends on the participation of an active citizenry who may provide input through a community of ideas. The Northern New Jersey Community Foundation should be applauded for fulfilling that role, bringing together a cross section of people interested in the issues that impact the lives of many Bergen County residents."

An example of local level confidence is that of the Mayor and Council of the City of Hackensack accepting the Foundation's recommendation for a consultant and process for introducing economy-boosting arts and culture elements to the city's multi-million dollar downtown revitalization plans. Volunteers organized by the Foundation will be working with the city to achieve its goals. At the County level, the director of the Department of Historic and Cultural Affairs has agreed to work with the Foundation in establishing an arts council for Bergen County. "ArtsBergen" will serve the county's interests as well as the Foundation's in supporting and promoting the arts throughout the County, increasing quality of life, and stimulating local economies.

Regarding "maintenance of ongoing bona fide programs for solicitation and sources of support."

1. Strategic Planning by the Board

The Foundation periodically conducts strategic planning meetings with its board members to discuss, evaluate, and plan programmatic and fundraising initiatives for the Foundation. In 2011 and in 2013 into 2014, the Foundation engaged in long-range strategic planning processes to discuss the direction and mission of the organization, and how to build a sustainable diversified funding stream. While these ongoing efforts have not been as successful as we planned, we are now confident that we have a team in place that can finally execute effectively the changes that we are initiating.

2. Grant Research

The Foundation regularly researches grants from government, corporate and foundation sources to find prospective matches with our programming and mission. In 2010-2011, the Foundation, in partnership with the NJ Chapter of the American Academy of Pediatrics, applied for and won a \$20,000 grant to run *Fit Families*, a pediatric obesity remediation program for parents of toddlers. In 2012, the Foundation contributed substantially to developing one of its current initiatives. ArtsBergen, a regional arts council that by unifying the many artists and arts programs in the area will brand Bergen County as an arts destination. Going into 2013 we applied for two grants focusing on the ArtsBergen project. First, in partnership with ArtsHorizons, a non-profit arts-in-education, metro-area organization and eight local municipalities, the Foundation applied for a National Endowment for the Arts "Our Town" grant in the amount of \$75,000. This was for an arts and culture initiative that would establish an arts council, conduct a cultural assessment and planning process, and brand the area for the arts. Months later we submitted a similar, though more limited, proposal to the local Community Chest for a \$20,000 "Impact" grant. Unfortunately, we were awarded neither. Later in the year, in response to Superstorm Sandy, we submitted a letter of inquiry for \$83,300 to the New Jersey Recovery Fund proposing a pilot program for a six-town regional innovation cluster. This was intended to improve the delivery of municipal services, reduce costs, and strengthen social capital by promoting long-term community resiliency and sustainability. Although we presented substantive ideas, we were not included among the finalists.

3. *President's Solicitation Efforts*

The Foundation's president solicits funds on an ongoing basis at his meetings with local community groups. We received \$4,000 from the Rotary Club. In 2014, his community outreach efforts resulted in raising \$6,700 from individual donors.

4. *Programmatic Fundraising*

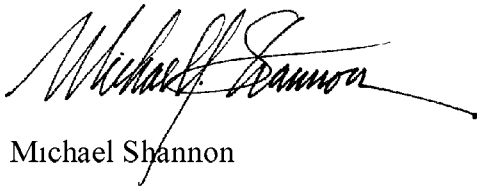
The Foundation has been working with its six-town "Community Collaborative" and has received \$7,500 to conduct a Government Services Index study. In 2012, the Foundation engaged ARTISIN, an arts and business consultancy, to assist in the development of ArtsBergen. In 2014 we completed its business plan, which includes plans for a fundraising campaign to support the program. We have formed a fundraising committee that has hired a professional fundraising consultant to assist in the design and implementation of an aggressive solicitation plan.

5. *Expansion of Donor Services Function*

The Foundation's recent focus on strengthening its donor services function has already resulted in raising close to \$20,000 over the past few months.

In closing, we respectfully request that you grant us time to reorganize the Foundation and broaden our public support thereby realizing the goals we have been working to achieve for seventeen years. A great deal of time, energy, and money has been spent in our good faith effort to improve the quality of life in Northern New Jersey. We have not yet achieved the level of success that we intend to, but we can, and ask that you give us a chance to prove it to you by allowing us to remain a public charity. This step will substantially encourage more active participation by the public in supporting our work in their behalf.
