The Fluid Power Laboratory Program helps to establish state-of-the-art training labs at qualifying educational institutions. These labs will be used by engineering students to study fluid power with the eventual goal of working in the fluid power industry after they graduate. One laboratory grant was awarded to one university.

4b (Code:) (Expenses \$ 49,403 including grants of \$ 49,403) (Revenue \$)

The Grant Program consists of research and teaching grants. Research Grants are awarded to projects that strengthen ties between individual researchers and industry and seeks to stimulate interest in fluid power on school campuses across the country. The program seeks to provide world-class university research on pre-competitive problems of wide interest to the fluid power industry with potential applications within five years. Teaching grants support projects that foster the study of motion control technology from middle through graduate schools with hands-on training initiatives, senior capstone projects, student competitions, the development of teaching tools, etc. One research grant was awarded to a university. Five teaching grants were awarded to three universities, one technical college and one community college.

4c (Code:) (Expenses \$ 1,700 including grants of \$ 1,700) (Revenue \$)

The Fluid Power Challenge is a skills competition and a classroom activity for 8th grade students. The program exposes student and teachers to real world engineering problem solving using fluid power technology. Approximately 700 students from 60 schools throughout the US participated in the 2013-14 competitions and classroom activities. Seven middle schools were awarded grants.
