Mental Health and Medical Services - APM maintains two behavioral health clinics that deliver a spectrum of bilingual and culturally sensitive treatment and prevention services to more than 2,000 Philadelphia residents without geographic restriction APM offers bilingual diagnoses and treatment for the community's mental health issues APM provides supporting housing programs to provide long-term help to the Hispanic homeless population by providing housing assistance and appropriate supportive services that help clients master the tools necessary for successful independent living

APM's Human Services Division provides Head Start Day Care services for children 3-5 years old for low income families who live within the neighborhood The level of day care service is based on families' income levels using a sliding scale As a bilingual organization, APM has no boundaries and accepts referrals all across the City of Philadelphia The Early Intervention program provides special education for children 3-5 years old with special needs, such as emotional, speech and physical therapy Case management is an integral service offered to homeless individuals and families to provide rental assistance to help families secure stable living Children, youth and family programs provide services to children in their own homes, recruit foster parents and offer adoption services APM provides shelter for families with small children until they are moved into transitional or permanent housing The Improving Outcomes for Children ("IOC") Intervention program is responsible for ensuring that the IOC has the necessary array of planned interventions, services, and supports necessary to achieve the conditions for safe case closure Additionally, this program is responsible to ensure that interventions are readily available for at risk families (both with and without active safety threats), have the sufficient power and beneficial effect to meet family needs, and are linked to an ongoing network of support for the families involved while being accessible to the surrounding community help in decreasing the number of cases accepted for service This program will also provide services that prevent delinquency but also preventing the onset of adult criminal careers reducing the burden of crime on its victims and on society The IOC is responsible for coordinating, integrating, and managing all child protective and child abuse and neglect prevention services in the designated geographic area in collaboration with DHS It is responsible for ensuring the continuity of care from entry to exit for all children, youth, and families referred by DHS The IOC will have the ability to directly provide, or contract for through community-based subcontractors, all necessary child protective and child welfare services The IOC is also responsible for meeting the outcomes and performance standards related to these services, and ensuring that subcontractors are licensed and complete any training required by DHS or DPW for the services they are providing
