Note 1. Organization and Summary of Significant Accounting Policies

Nature of operations:

The Bridges Foundation is a nonprofit corporation established to provide support for the students and faculty of Bethlehem Area Vocational-Technical School. The Foundation provides scholarships, equipment and special academic opportunities for area students. Revenue and support is obtained primarily from private industry in the Lehigh Valley area.

Basis of accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Revenues are recorded when earned and expenses are recorded when incurred.

Basis of presentation:

The Organization has adopted the provisions of FASB Accounting Standards Codification (ASC) 958-210, "*Accounting for Contributions Received and Contributions Made*", and "*Financial Statements of Not-for-Profit Organizations*". FASB ASC 958-210 establishes accounting standards for the treatment of contributions and pledges and requires uniform financial statement classification by non-profit organizations to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. Net assets, revenues, expenses, gains and losses are classified based on the existence or absence of donor imposed restrictions. Accordingly, net assets of Bethlehem Area Vocational-Technical School Bridges Foundation are classified and reported as follows:

Unrestricted net assets

Net assets that are not subject to donor imposed stipulations are classified as unrestricted net assets.

Temporarily restricted net assets

Net assets subject to donor imposed stipulations that may or will be met, either by actions of Bethlehem Area Vocational-Technical School Bridges Foundation and/or the passage of time are classified as temporarily restricted net assets and reported on the Statements of Activities as net assets are released from restrictions.

Permanently restricted net assets

Net assets subject to donor imposed stipulations that neither expire by passage of time nor can be fulfilled or otherwise removed by actions of the organization. As of June 30, 2014, Bethlehem Area Vocational-Technical School Bridges Foundation had no permanently restricted net assets.

Cash and Cash Equivalents:

For purposes of the statements of cash flows, the Foundation considers all highly liquid investments available for current use with maturities of three months or less at the time of purchase to be cash equivalents.

Investments:

Investments in marketable securities with readily determinable fair values and all investments in debt securities are reported at their fair values in the statement of financial position.

Scholarships Payable:

Scholarships are accrued when awarded by the Foundation and are unconditional. Scholarships are made from designated donor contributions and available investment principal and income.

Income taxes:

The Bethlehem Area Vocational Technical School Bridges Foundation is a nonprofit organization as described in Section 501(c)(3) of the Internal Revenue Code and is exempt from federal and state income taxes.

The Organization files a Return of Organization Exempt from Income Tax annually. No provision for income taxes is made in the accompanying financial statements as the Foundation has no activities subject to unrelated business income tax and the Foundation is not a private foundation.

The Organization's returns for 2011, 2012 and 2013 are subject to examination by the Internal Revenue Service, generally for three years after they were filed.

Contributions:

Contributions are generally available for unrestricted use unless specifically restricted by the donor. Unconditional promises to give (pledges) are recorded as received. Unconditional promises to give due in the next year are reflected as

current promises to give and are recorded at the pledge value. Unconditional promises to give due in subsequent years are reflected as long-term promises to

give and are recorded at the pledged value. The majority of the promises to give are received from local businesses as a result of an annual campaign.

Contributions received are recorded as unrestricted, temporarily restricted or permanently restricted support, depending on the existence and nature of any donor restrictions. Donor-restricted support is reported as an increase in temporarily or permanently restricted net assets, depending on the nature of the restriction. When a restriction expires (that is, when a stipulated time restriction ends or purpose restriction is accomplished), temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions.

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Functional Allocation of Expenses:

The costs of providing the Organization's program and activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated amongst the program and services benefited.

Date of management's review:

In preparing these financial statements, the Organization has evaluated transactions for potential recognition or disclosure through November 14, 2014, the date the financial statements were available to be issued.

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were used for the year ended June 30, 2014.

Note 3. Educational Improvement Tax Credit (EITC)

The Bridges Foundation is an educational improvement organization as defined by the Pennsylvania Department of Community and Economic Development. As such, businesses that contribute to this organization may receive a tax credit equal to 75% of its contribution (90%, if contributions are for two consecutive years) up to a maximum of \$100,000. In order to maintain educational improvement organization status, the Bridges Foundation must use 80% of its annual receipts from businesses receiving tax credits towards programs providing tuition for innovative educational programs supporting advance training.

The Organization has elected to consider donations received under the PA Department of Community Development Educational Improvement Tax Credit to support tuition for educational programs as restricted funds.

Note 4. Board Designated Net Assets

As of June 30, 2014 and 2013, Board designated net assets totaling \$49,032 and \$26,874, respectively, consist of unrestricted net assets designated by the Board for scholarships.

Note 5. Temporarily Restricted Net Assets

Temporarily restricted net assets consist of funds restricted for scholarships, EITC, educational program funds and Adam Fink Memorial funds. The Organization began receiving funds from the Adam Fink Memorial Fund in October 2006 and amounts received for this fund are restricted for media arts scholarships and equipment.

As of June 30, 2014 and 2013, the Organization had temporarily restricted net assets available for the following purposes.

Note 6. Concentration of Credit Risk

Financial instruments which potentially subject the Organization to concentrations of credit risk consist principally of cash balances in excess of insured limits. At times during the year, the Organization's cash balance has been in excess of the federal insurance limit of \$250,000. The organization has not experienced any losses as a result of these balances.
