We are focused on adequate and equitable school funding, access to qualified and effective teachers and promoting college and career readiness for all students. During the 2013-14 fiscal year, we worked to implement the state's new weighted student funding formula (Local Control Funding Formula or LCFF) before the State Board and in local districts across the state. LCFF directs additional resources to disadvantaged students, increases local district spending flexibility and heightens requirements for engaging the local community in those spending decisions. Public Advocates led advocacy at the State Board of Education for strong regulations governing LCFF implementation, especially requiring that funds generated by low-income students, English learners and foster youth are used to improve programs and services for them and defining a key role for parents and the community in local. Housing, Transit & Climate Justice We work to spur equitable growth and access to opportunity for low income communities and communities of color throughout metropolitan regions by promoting affordable housing, protecting low-income communities from displacement, and increasing the availability of local transit through coalition-building and legal and policy advocacy at the local, regional, state and federal levels. Public Advocates achieved significant progress on behalf of disadvantaged communities during 2013-14 with the passage of a state budget that allocated a substantial share of Cap-and-Trade revenues to affordable housing and sustainable communities (\$130m) and low carbon transit operations (\$25m), with continuous appropriations to be made in future.
