Webb Medical center (a 305-bed nationally recognized acute care hospital), Banner Sun Health Research Institute with research focus on diseases of the aging, and other activities including Nursing Education, Banner Oliver Branch Senior Center, La Loma Care Center, Grandview Terrace Care Center, Grandview Terrace Memory Support Suites, the Centers for Health and Wellbeing, Care Transitions program, Community Education and Sun Health Hospice homes. The Foundation also directs funds from its resale gift shops to both Banner Boswell and Del. E. Webb Medical Centers. The Sun City West resale shop, in partnership with the Sun City West Foundation, directs certain proceeds for localized transportation services that benefit area seniors.

All deposits are employer contributions. Should a participant voluntarily terminate employment prior to a deposit vesting, the deposit is forfeited. All deposits are paid out and taxed upon vesting. Mr. Ronald Guziak received a 457(f) payment of \$49,234.

Part II Effective 9/2/2008, the compensation for officers and key employees was paid by Banner through an agreement between Banner Health and Sun Health Foundation. Banner Health is a separate unrelated 501 (c) 3 organization. Sun Health Foundation reimburses Banner Health for the amount paid.
