THE HAVEN SAW 60% OF ITS RESIDENTIAL TREATMENT CLIENTS COMPLETE THEIR 60-90 DAY TREATMENT PROGRAM. WE SAW 218 CLIENTS IN FISCAL 2014. OF THESE WOMEN ONLY 14 WERE NOT PUBLICALLY FUNDED. OF THE PUBLICALLY FUNDED CLIENTS 80% OF THE CONTRACTS ARE LESS THAN THE MEDICAID RATE AND LESS THAN OUR COST. ADDITIONALLY, 54 WOMEN AVOIDED THEMSELVES OF OUR TRANSITIONAL HOUSING PROGRAM.
