SHELTERCARE PROVIDED EMERGENCY SHELTER AND SUPPORT SERVICES TO 56 HOMELESS FAMILIES WITH CHILDREN AND PROVIDED HOMELESSNESS PREVENTION SUPPORT AND SERVICES TO 141 FAMILIES INCLUDING THOSE IN THE CHILD WELFARE SYSTEM. SHELTERCARE'S HOMELESS MEDICAL RESPITE PROGRAM SERVED 50 INDIVIDUALS. 
