Extended Day (ED) program - now at both Marshall and Bryant Elementary Schools in San Francisco, focuses on positive youth development outcomes and helping needy children excel academically. The ED served 250 children across both sites, spanning K-5th grades. Implementing the program's logic model, the ED program supported the English Language acquisition and success of our students through literacy/fluency curriculum and activities. Intentionally weaving literacy-building opportunities into not only the classroom, but also into all enrichment activities, we continued to support students in reaching grade-level proficiency in English Language Arts. Students are involved in literacy-strengthening activities such as America SCORES poetry, theater, and cooking with healthy recipes. The ED has five central program components: 1) Academic enrichment and guided reading interventions; 2) Project-based "elective" activities that incorporate literacy-building opportunities throughout each project cycle; 3) Sports and Recreation; 4) Community-building activities that help to foster group cohesion, build social skills, and model resiliency; and 5) College Connect, our early college awareness program that aims to prepare and motivate children to plan for college. Parent involvement is a key strategy to our success and over 125 parents regularly attend math, literacy and science nights.

College Connect began work with its 7th cohort of first-generation high school students, growing our numbers to serve 140 high school and college students, and 12 College graduates. 93% of our College Connect students continue to pursue their college education, 4 times higher than the California average rate of 23% for Latino students. Our most recent cohort raised over \$696,750 in scholarships, averaging almost \$28,000 per student. To date, our College Connect students have raised over \$2.5 million in college scholarships. juniors who would be the first in their family to attend college, surround them with caring adult experts in college admissions as well as a cohort of peers who are just as committed to attending college, and supports them and their families all the way through college graduation. While participating in our program, students are provided training on college entrance exams, coaching in developing a personal statement, support in navigating the world of financial aid and scholarships, and suggestions on colleges and universities that will best meet their needs.

Parent Partner Program continued to promote parent engagement at Mission schools, increased programming to 5 Mission school sites, reaching 780 parents. Our foundational parent programming is the Believing the College Dream parent platicas (chats), a year-long series of parent-led workshops developed with UC Berkeley's Center for Educational Partnerships. This year, we implemented these workshops at 4 partner schools. We worked closely with 4 partner schools to support the development and leadership of their English Language Advisory Committees (ELACs). We also increased our skills-based training for parents, providing training on Math skills and games, "How to talk to your child about what they are Reading," and a year-long family literacy program called Sopa de Letras. We significantly expanded the number of schools where we offer parent English Language Development Classes to 5, providing over 10 hours a week of instruction to parents.

College Connect participation and attendance is a strong indicator of the student's ability to maintain communication while in college. A student with poor communication and low attendance will likely demonstrate this while in college, and is at risk for low academic performance and dropping out. Citizenship is also a factor because of the limited options for financial aid, educational grants, and scholarships for students that are not citizens. Recipients are then selected based on their outstanding financial need (after other financial aid sources are included) and program involvement.
