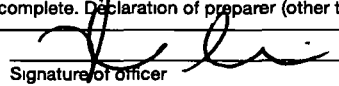

WHILE THE ORGANIZATION'S EXPERTISE IS WORKING WITH MONOLINGUAL SPANISH-SPEAKERS, IT PROVIDES SERVICES TO ALL LOW-INCOME PEOPLE IN NEED REGARDLESS OF RACE OR ETHNICITY.
