FURTHERMORE, IN AN EFFORT TO COMFORT MOTHERS, NICU IS EQUIPPED WITH "ROOM-IN" QUARTERS WHERE MOTHERS CAN RECEIVE PERSONAL TRAINING AND ASSISTANCE FROM NURSES, AS IT RELATES TO THE CARE OF THEIR NEW INFANTS.
