Program Service I MEDICAL AND SCIENTIFIC RESEARCH GRANTS The ABTA's historical support of young, talented researchers working to improve brain tumor diagnostics and treatment has contributed to populating the modern brain tumor research and scientific community Many of the young scientists we have supported have gone on to mentor new researchers and to lead some of the nation's most prestigious brain tumor centers In addition to supporting young investigators, the ABTA funds discovery science which encourages the development of new approaches to the diagnosis and treatment of brain tumors These awards "de-risk" novel research by allowing researchers to conduct the early scientific studies needed to secure additional funding for their projects Interest in these new concepts has been shown by the NIH and venture capitalists, who have provided "follow-on" funding at significantly higher levels than the ABTA's grants The development of new diagnostic and therapeutic approaches advances the understanding and treatment of brain tumors, and increases the potential for improving, extending and ultimately saving the lives of those living with a brain tumor diagnosis An independent, multi-level, external review process ensures that ABTA grants are awarded to the brightest and most forward thinking researchers Our prestigious Scientific Advisory Council and grant reviewers are leaders in the brain tumor community Many were themselves recipients of ABTA funding earlier in their careers We also collaborate with other research funders, both in and out of the brain tumor field, to expand the understanding of this disease We support research that will improve the quality of life of brain tumor survivors and their caregivers The ABTA Alumni Research Network ensures research collaborations into the future Through this forum, ABTA grant awardees share ideas and gain insights that will shape their careers and the brain tumor landscape The American Brain Tumor Association's Research Funding Program Supports early career development through - BASIC RESEARCH FELLOWSHIPS \$100,000 two-year training awards for new and early career scientists wishing to learn brain tumor research skills Through these awards, the ABTA is supporting the early careers of brain tumor researchers An ABTA Basic Research Fellowship is a highly regarded, and often the first, award of a new investigator's career To date, we have brought over 250 researchers into this field, or encouraged them to remain in brain tumor research, via ABTA Basic Research Fellowships Many transitioned into leaders of brain tumor research laboratories and treatment programs, and now serve as mentors to new scientists entering the field - Medical Student Summer Fellowships \$3,000 summer stipend grants which allow medical students to spend a summer in a brain tumor research laboratory These awards are one of the most exciting areas for the ABTA to fund as they are so meaningful to these enthusiastic students embarking on their careers The experience makes this disease better understood as medical students study tumor cells while learning the research lab skills that could lead to scientific breakthroughs Through this experience, the students are exposed to the research challenges confronting this disease Supports innovative research through - Discovery Grants \$50,000 one-year awards in support of new concepts with the potential to change the way brain tumors are diagnosed or treated Discovery Grants, while considered the most "high risk/high impact" of our funding areas, carry the highest opportunity for reward and innovation To date, 32 of these grants have been awarded Concepts supported through this funding must be capable of changing the way brain tumors are diagnosed or treated Funding has been provided for the development of new treatment approaches and advanced approaches to tumor detection ABTA Discovery Grant funding recently aided the development of two new brain tumor drugs that target malignant gliomas such as glioblastoma multiforme (GBM)-a common and aggressive type of malignant brain tumor Both drugs represent new approaches to this most aggressive and challenging type of tumor Supports collaborative funding opportunities - Collaborative Initiatives These efforts support jointly sponsored feasibility, clinical research, and quality of life studies These grants provide support to projects more effectively performed across multiple organizations or funders Most recently, ABTA collaboratively awarded a \$2 million, two year study that seeks to better understand the characteristics of long term survivors of glioblastoma The research seeks to identify commonalities and unique differences among a group of 5 year + survivors of this often fatal disease

Program Services II BRAIN TUMOR INFORMATION AND EDUCATION The American Brain Tumor Association is a trusted resource for brain tumor patients, caregivers and health care professionals around the country Our team of health care professionals respond daily to requests from patients and families seeking assistance in understanding a diagnosis or treatment, or in navigating the complexities of the health care system From a wide range of publications to webinars and educational programs, our goal is to ensure that brain tumor patients, their families and those who care for them have the tools and information they need from the point of diagnosis and throughout the trajectory of the disease The ABTA provides - Educational information for pediatric and adult patients at www.abta.org - Professionally Reviewed Print Publications - Specific brain tumor information from diagnosis through treatment are available at no charge to patients and families Most are available in downloadable format and in Spanish - Our team of health care professionals provides one on one information services by phone or by email, assists patients and caregivers in navigating the health care system and accessing resources that meet their needs - Our "Connections" online support community connects patients, families, caregivers and friends for support and inspiration There is no charge for membership, and the site is available 24/7 - ABTA TrialConnect assists patients interested in enrolling in a clinical trial - Monthly webinars are free, hour-long monthly webinars on topics of interest (general and pediatric-focused) for brain tumor patients, families and health care professionals Webinars are recorded and can be viewed at any time on the ABTA website This year, the webinars were viewed almost 13,000 times - An annual national, patient-centered conference bringing the nation's leading experts together with patients and their families to share brain tumor research, treatment and care trends and information as well as opportunities to interact with ABTA-funded researchers and network with others - Outreach to and collaboration with health care institutions to promote and enhance brain tumor education and awareness locally - Updates on brain tumor care and treatment through our semiannual newsletter, monthly electronic communications, and regular website postings at www.abta.org This year, the ABTA supported almost 4,000 exchanges through its CareLine between healthcare professionals and patients, families, caregivers or others seeking help and support in understanding their diagnosis and treatment, assistance navigating the complexities of the health care system and access to local resources A full range of services and resources are offered, including educational publications, information about community resources, updates on advances in brain tumor care and treatment, and regional meetings for patients, family members and caregivers The ABTA saw continued growth of its Connections online social networking site this year Located at www.abta.inspire.com, the site brings together patients, family members, friends and others in similar circumstances to share stories, information and inspiration This year, the Connections online community grew to nearly 4,500 members The ABTA is also an advocate for brain tumor patients and their families We give voice to the needs of brain tumor patients in legislative and regulatory health care issues through our alliances with such organizations as the National Organization for Rare Disorders (NORD), the Patient Advocacy Foundation's Regulatory Education and Action for Patients (REAP) group, and the Alliance for Childhood Cancer

Program Services III HEALTHCARE PROFESSIONAL OUTREACH The ABTA brings to the health care professional community the tools to assist them in providing their patients and their patients' caregivers with up-to-date information, opportunities to help them better understand the impact of a brain tumor on the lives of patients and their families, and collaborations that will advance new approaches to the diagnosis and treatment of brain tumors Through its relationships with healthcare providers and collaborative efforts between organizations, institutions and researchers, the ABTA adds to the knowledge of the impact of this diagnosis on patients and their families We do this by - Assessing the informational needs of health care professionals relative to the ABTA's offerings in the areas of a) educational information being sought, b) their preferred manner of receiving educational information, and c) the ways in which this information is extended to their patients and caregivers - Actively participating in professional organizations such as the Society for Neuro-oncology, Oncology Nursing Society, Health Research Alliance, American Society for Clinical Oncology, and the American Association of Neuroscience Nurses These organizations provide the ABTA with opportunities to enhance our visibility within the brain tumor clinical and scientific communities The ABTA also supports the Response Assessment in Neuro-Oncology annual meeting at which scientists and clinicians are working together to develop guidelines for measuring patient response to treatment - The ABTA participated in the creation of new brain tumor clinical practice guidelines for both adult and pediatric patients through a collaboration with the American Association of Neuroscience Nurses - ABTA participates in the periodic review of clinical treatment guidelines of the National Comprehensive Cancer Network

At the Board meeting, the Chair entertains a motion to authorize the President & CEO to sign and submit the draft as presented or as amended through discussion. A majority of those present can approve the motion. If a Board meeting is not scheduled within thirty days of the submission date, all Board members will be sent a copy of the Form 990 and attachments electronically at least thirty days prior to the submission date. Directors are encouraged to ask questions about, raise issues about, and indicate support for the draft within ten days. Such feedback can be sent to the President & CEO, the Board Chair, or the Treasurer by email or other form of delivery as long as it is received within the ten days. If a Director does not respond within the ten day period, it will be considered that the Director is satisfied with the document as drafted. Any issues raised by Directors within ten days after receiving the draft Form 990 will be reviewed and resolved by the President & CEO, the Treasurer, and a simple majority of the members of the Board's Finance Committee in collaboration, with assistance as needed from the tax preparer. A summary of the changes made to the draft Form 990 and the reasons for the changes will be emailed to all Directors ten days or more before scheduled submission.
