Promote and support educational opportunities of students and coaches in South Dakota. Scholarship awards during the year were nine (9) \$1,000 scholarships. A donation of \$3,000 went to Special Olympics South Dakota. Donations of \$500 were made to two (2) organizations (Make-A-Wish and SDFCA) for a total of \$1,000. Eight (8) grants in the amount of \$700 each for a total of \$5,600 were awarded to coaches to attend a national clinic or seminar. Assistance in the amount of \$10,100 total was given to nineteen (19) coaches to attend a national clinic. The organizations all contribute to the exempt purpose of the organization. The organization also provides coaches across the state a clinic to better themselves for the benefit of students they coach. Grants to other charitable organizations included \$18,324 to South Dakota Coaches Foundation and \$30,000 to Coaches Against Cancer. (Grants \$ 77,024)
