UFM Community Learning Center is a creative educational program serving Kansas State University, the Manhattan, KS, area and the state of Kansas. UFM provides opportunities for lifelong learning and idea exchange. UFM also serves as a catalyst and host for new programs and services that enhance the quality of life for all.

UFM Educational Program: This is UFM's largest program and primary mission activity. The educational program offers a wide variety of noncredit and credit courses and workshops. In FY14 UFM offered 829 noncredit courses and 175 courses offered for credit through Kansas State University. 3,510 (unduplicated) persons took noncredit courses and another 2,353 students received K-State credit. Class topics included aquatics, creative free time, foods and nutrition, earth and nature, health and wellness, recreation, languages and martial arts. Total participation in all UFM activities was 17,439.
UFM is the sole Licensed Training Provider for the American Red Cross in the Manhattan area and is the largest provider in Kansas. UFM collaborated with many other organizations to serve the community and participated in several community awareness activities.
UFM continued to coordinate Osher Institute classes in collaboration with Kansas State University and the University of Kansas
UFM hosted the Community Campaign for Nonviolence and the Flint Hills Renewable Energy and Efficiency Cooperative offices as a community service.

4b (Code:) (Expenses \$ 61,110 including grants of \$) (Revenue \$ 51,281)
Manhattan Area Risk Prevention Coalition (MARPC): UFM administers funds on behalf of MARPC, a coalition of 12 community sector representatives. The focus of the coalition is risk reduction and prevention among youth, especially alcohol/drug use issues and prevention activities. In FY14, MARPC received the second year of a three year grant from the Kansas Department of Disability and Aging Services. The focus of the grant is a media campaign on social hosting and messages on ways parents can talk to their children about alcohol use. MARPC continued to sponsor the Manhattan High School After Prom event. This year, partnerships were enhanced with Fort Riley and Kansas State University.

Teen Mentoring Program: The Teen Mentoring Program offers a structured program of support and life skills to youth in grades 7 - 12. Project goals for the teens include learning positive life skills and focusing on primary prevention and intervention activities. Students from Kansas State University serve as mentors. Participant referrals come from the schools, community corrections, parents and teen participants who bring their friends. In FY14, 35 youth were served and 14 K-State students volunteered as mentors.

Low cost garden plots are available to Manhattan and Riley County residents. Print newsletters are produced three times during the growing season. An e-newsletter is sent weekly. Power tools, some hand tools and hoses are provided. Land is leased from the City of Manhattan and Riley County. In FY14, 182 families gardened 286 plots.

Part III. 4d. 2. Project EXCELL (Extending College Education for Lifelong Learning). Expenses - \$12,920 Grants - \$0 Revenue - \$11,038

EXCELL provides area adults with mild developmental/intellectual disabilities enrichment and job readiness classes in a college-like environment. Traditional college students serve as mentors and classroom aids. Classes are held on Saturday mornings during the fall and spring semesters. In FY 14, 60 participants enrolled. 20 KSU students assisted.

Part III. 4d. 3. Lou Douglas Lectures. Expenses - \$ 13,007 Grants - \$0 Revenue - \$12,805

This lecture series brings speakers to the K-State campus. The overall theme of the series is social justice, human rights, world peace and international development. In addition to lectures, the speakers often visit K-State classes, meet with student groups and, when appropriate, participate in campus and community events. In FY14, speakers included Sandra Praeger, speaking on Kansas health insurance reform, Edward Wolff speaking on income disparity and John Hofmeister speaking on leadership. Sandra Praeger, the Kansas Insurance Commissioner, was paid \$79 in travel reimbursement for attending the lecture she gave in September, 2013, as reported in

Part IX.18.

Part III. 4d. 4 Community Youth Scholarship Fund. Expenses - \$3,035 Grants - \$3,004 Revenue - \$3,420

UFM coordinated the distribution of recreation scholarships for low income youth in Manhattan, KS. Funding was provided by the City of Manhattan and private donations. This program was discontinued in December, 2013. In FY14, 64 scholarships were awarded for youth participants in a variety of local youth programs.
