SCHOLARSHIP PROGRAM: ALTHOUGH THE COLLEGE'S TUITION IS THE LOWEST IN NORTHEAST OHIO, THERE ARE STUDENTS IN OUR COMMUNITY WHO, WITHOUT SOME FINANCIAL ASSISTANCE, ARE UNABLE TO ACCESS OR CONTINUE THEIR EDUCATION. SCHOLARSHIPS ENHANCE ACCESS TO HIGHER EDUCATION AND SUPPORT THE ULTIMATE GOAL OF EXPEDITING STUDENT TRANSITION THROUGH COLLEGE AND REDUCING THEIR TIME TO GRADUATION.
