Annual Campaign for the Arts This annual arts fund is designed to raise funds to provide grants for general operating support to local arts organizations, while simultaneously increasing awareness of the importance of arts and culture to the quality of life we enjoy in the Dayton Region. Culture Works brings arts performance and information to over 40 workplaces to encourage employee engagement, arts participation, and financial support.

Power2give Culture Works began hosting the nationally franchised on-line cultural marketplace, Power2give, in 2014. Power2give, allows all nonprofits in the 8-county Dayton Region to post and promote projects in need of funding. Culture Works secures matching funding for projects, provides administrative support, and issues grants for the full amount raised on-line plus any matching funding at the conclusion of the project posting.

Cultural Planning Culture Works undertook a regional cultural planning process consisting of seven phases, three of which were completed during this year. The consulting firm of WolfBrown is managing the project, with researchers from the University of Dayton and Wright State University assisting in information gathering and synthesis. A significant outcome of the project in 2013, was the completion of a study which substantiated the economic impact of the arts and cultural sector in the Dayton Region to be 161.3 million annually.

Access to Arts & Culture Culture Works provides a regional calendar of arts and cultural events that continually updates, and provides social media encouraging attendance to free events and festivals. Additionally, Culture Works surveys the community regularly to determine barriers to access to the arts and investigates methodologies to overcome these barriers.

Arts Advocacy Program Culture Works advocates locally, regionally, and nationally for arts and culture. Legislative visits are coordinated by Culture Works for the annual Arts Day in Columbus each year, and Culture Works plays an active role in the nomination process for the Governor's Awards for the Arts. Culture Works communicates with elected officials throughout the year, and sets up meetings with Mayors, City Councilman and others interested in meeting with area arts groups and responding to questions and requests for information from state, city, and county elected officials and staff and attends national conferences to ensure that national funders and federal agencies are fully informed about the cultural assets of the Dayton Region.

Economic & Development Program Culture Works serves as a central clearinghouse for cultural information about the Dayton Region, providing an annual Guide to Arts & Culture in the Dayton Region and a website that links to more than 250 cultural organizations and festivals. Additionally, the organization organizes the Cultural Arts Day for Leadership Dayton, speaks to multiple groups throughout the year including the Board of Realtors and Economic Development entities to increase awareness of the arts sector and its relationship to economic and community development.

Focus on the Arts Program Free performances and visual art exhibitions are provided at a variety of non-traditional performance venues, including Wright-Patterson Air Force Base, workplace giving sites, and other public settings, to increase awareness of local arts and culture to a diverse group of citizens.

(Code) (Expenses \$ 12,000 including grants of \$ 3,500) (Revenue \$)

Leonard P. Roberts Memorial Scholarship In recognition of Mr. Roberts' career as a businessman and his passion for the arts, Culture Works offers scholarships to junior or senior students attending selected 4-year institutions of higher learning in the Dayton region. Students must be enrolled full-time and demonstrate participation in or patronage of the arts, as well as financial need.

Passport to the Arts Program Culture Works manages and promotes a program that provided 2-for-1 tickets to a variety of performances, and discounted memberships to arts organizations, restaurants, and other venues.

Grant-making Culture Works develops processes and procedures for overseeing and adjudicating grant applications, recruits and trains panelists, provides grant-making workshops for applications, communicates with prospective applicants, panelists, and grant recipients, attends meetings specific to grants, evaluates outcomes, and promotes the grant process.
