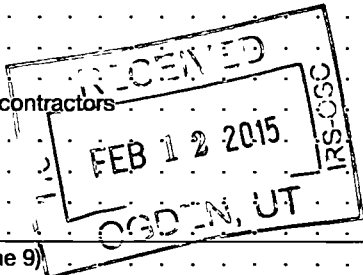



The College Hill Foundation was formed in 2008 and then filed for non-profit status. The original Board of Directors was attempting to purchase an abandoned school building in College Hill as a facility for various community activities. Clear title was never presented so the building could be purchased. The Foundation became inactive until July 2012 when a new Board was elected with several previous members staying on the Board for continuity. Since then the CHF Board has studied how best to be of service to the College Hill neighborhood. No significant actions occurred until the current fiscal year ending June 30, 2015. This has always been a volunteer board with no employees or compensation for Board members. The current Board received a treasury consisting of \$605.00.
