Wish granting is One Simple Wish (OSW)'s core program and offers caring individuals a way to directly affect the life of a child in foster care. Through our website, potential donors are able to browse hundreds of wishes posted on behalf of the children and select which wish to grant. The wishes typically cost from \$5 to \$500, which allows almost anyone to find a wish that speaks to both their heart as well as to their budget. Moreover, OSW recognizes that donors have a desire to know exactly where their contributions go and therefore offers the opportunity for them to give more efficiently and effectively. When a donor grants a wish, nearly 100% of that donation is directed towards fulfillment of that specific request. During the fiscal year, thanks to the generosity of thousands of people, OSW granted 3,416 wishes.

Wish to Work focuses on young adults who have aged out of the foster care system. This means they have reached the age of 18 (or up to 21 in some states) and were not reunited with their biological families or adopted. Children who age-out of the system face grim futures, being much more likely to become teen parents, to experience homelessness, or to end up in prison or addicted to drugs. Wish to Work offers foster children ages 16+ an opportunity to prepare for and obtain some of the skills and experiences that will aid them in becoming self-sustaining, successful adults. Wish to Work offers a series of networking events, seminars, lectures and trainings led by local business professionals that focus on giving these young people the tools necessary to find and secure jobs or internships in a variety of industries.

The Ohana Project is an extension of our services designed to help children who are removed from their homes due to abuse and/or neglect experience a smoother transition into temporary foster care. Each year nearly 5,000 children enter the foster care system in NJ. Our goal is to provide 24/7 access to baby supplies, personal care items, birthday gifts and basic needs to children in foster care and that have aged out of foster care in the state of NJ.
