Maryland-DC Campus Compact (MDCCC) promotes the public purposes of higher education by connecting campuses with their communities throughout the MD-DC region. MDCCC is a membership association of college and university presidents and their institutions committed to promoting engaged citizenship as an aim of higher education. MDCCC serves its member institutions through networking, grants, resources and programs with the goal of developing deeper campus-community partnerships.

MDCCC addresses and alleviates poverty in the Maryland-DC area through (1) our federally funded MDCCC AmeriCorps-VISTA grant. Through this grant, in FY14 we provided 22 full-time program coordinator positions to 22 of our member campuses helping them provide value of over \$1.1mil. According to the National Campus Compact annual survey, our member institutions contributed \$350 million (by volunteering) to the Maryland and DC communities this past year. MDCCC also provides 50 students with a partial scholarship valued at \$1,175 for performing 300 hours of service through direct mentoring of at-risk youths. Service included tutoring building homes for low-income people though Habitat for Humanity, and providing assistance at medical clinics. Through these and other initiatives, MDCCC continues to provide networking and professional development opportunities for our member institutions and community partners. In doing so, we are strengthening their ability to deepen and enhance their community partnerships and service-learning programs to build a culture of civically-engaged lifelong learners and active citizens. MDCCC annually sponsor and co-sponsor over 15 conference and workshop-style networking and professional development events, including service-learning and civic-engagement conferences, service-learning workshops, grant writing workshops, and an annual retreat for service-learning and civic engagement practitioners.

Conflict of Interest Policy Statement

Article I. Purpose

The purpose of a conflict-of-interest policy is to protect an organization's interest when it is contemplating entering into a transaction or arrangement that might benefit the private interest of one of its officers or directors, or might result in a possible excess benefit transaction. This policy is intended to supplement, but not replace, any applicable state and federal laws governing conflicts of interest.

Article II. Definitions

1. Interested Person

An Interested Person is any director, principal officer, or member of a committee with governing board delegated powers who has a direct or indirect Financial Interest, as defined below.

2. Financial Interest

A person has a Financial Interest if the individual has, directly or indirectly, any actual or potential ownership, investment, or compensation arrangement with MDCCC or with any entity that conducts transactions with MDCCC.

A Financial Interest is not necessarily a conflict of interest in all cases. Under Article III, Section 2 of IRS Form 1023, a person with a Financial Interest may have a conflict of interest only if the appropriate governing board or committee decides that a conflict of interest exists.

Article III. Procedures

1. Duty to disclose

In connection with any actual or possible conflict of interest, an Interested Person must disclose the existence of the Financial Interest and be given the opportunity to disclose all material facts to the directors and members of the committees with governing board-delegated powers considering the proposed transaction or arrangement. In an effort to aid such disclosure, each member (board, committee, or staff) shall complete a conflict-of-interest questionnaire as circumstances warrant, but no less frequently than annually.

2. Determining whether a conflict of interest exists

The Board shall review each member questionnaire and any other disclosures regarding the Financial Interests of its members. After disclosure of the Financial Interest, the Interested Person shall leave the board meeting while the remaining board members discuss and vote on whether a conflict of interest exists.

3. Procedures for addressing the conflict of interest

After exercising due diligence, the Board or committee shall determine whether the organization can obtain with reasonable effort a more advantageous transaction or arrangement from a person or entity that would not produce a conflict of interest. The Interested Person shall not be present in the room during the determination. If an alternative transaction or arrangement is not possible, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the best interests of the organization, for its own benefit, and fair and reasonable. Based on these determinations, the board or committee shall make its decision on whether to enter into the transaction or arrangement.

4. Board/Committee action

If the committee has reason to believe an individual has failed to disclose actual or potential conflicts of interest, it will inform the member and allow him/her to explain the alleged failure to disclose. If the committee still has reason to believe a conflict of interest exists after the alleged conflict is explained, it will take appropriate action.
