Meals are prepared and served every Thursday evening and Saturday morning by teams of volunteers from surrounding churches, schools, service clubs and businesses. Representatives from several different resource agencies are often available to give our guests the opportunity to ask questions, receive information and meet with professionals. We serve an average of 210 people per week.

Kids Club - Held during the school year, this is a school program for students grade k-6. The program operates daily from after school until 6:00p.m. at Spinning Elementary School. Kids Club offers elementary students a safe place to do homework, participate in educational activities and engage in free play.

Senior Cafe was created to provide area seniors with a twice weekly gathering to help seniors stay connected to community and to each other. The goal of the program is to help seniors maintain healthy, active, and independent lifestyles. This program is free and open to anyone over age 55.
