This is a program started in 2012 to conduct sustainability leadership training academy or persons within both public and private sectors. The objective of the training program isto make key staff members more cognizant o ways of improving sustainability processes within their respective organizations as well as individual professional development in terms of leadership styles, effective communication, etc. all through the lens of creating sustainability advocates in our community via an intentional public/private collaboration. This is a mission related program service and is offered 2 - 3 times each year.

4b (Code: SAP) (Expenses \$ 95,000 including grants of \$ 50,000) (Revenue \$ 100,000)
These funds, granted to Green Chips in prior years , were used to complete the installation of solar photovoltaic, solar thermal, and energy efficiency retrofits of local nonprofits. This year, the funds were used to complete a solar tre installation of the iconic "Welcome To Las Vegas" sign. The installation completely offsets the energy use of the sign.

4c (Code: Web Portal) (Expenses \$ 31,030 including grants of \$ 40,000) (Revenue \$ 40,000)
The web portal is greenchips web site as well as an online sustainability resource for the general public. The portal will focus on 8 areas of sustainability: water, energy, transportaion, economic development, recycling, education, the environment and health & lifestyle. Last year was the initial development phase of the portal and it was launched this year. The portal informs the public of relevant upcoming events, examples of sustainability programs offered by public agencies, businesses and corporations, and other non profits, as well as providing a wealth of information, links, and other resources. This program is funded almost entirely by a grant specifically for the program and all expenses are drawn down from that grant.

program administered by Nevada State Bank, under a contractual agreement between the bank and Green Chips. Convene for Green is a flagship program for Green Chips. The yearly event and ongoing community engagement brings together leaders from all sectors of the community to implement a "road map for sustainability." The costs are associated with those to conduct the conference and revenues are from sponsorships. Expenses = \$6,545; Revenues = \$38,991

The other program is promotion of a low interest loan fund for the local Home Performance with ENERGY STAR program in the state. Green Chips, hold the custodial account that backs the CD that acts as a loan loss reserve as mentioned in other areas of the return. However, the program associated with it is just to promote the financing program to the community via the web portal. Expenses = \$0; Revenues = \$6,288

Part VI, 4: Green Chips amended its Bylaws to give day-to-day management of the organization to the Board of Directors, as opposed to the Trustee Board, where that power previously sat, to allow the organization to be more agile and limit delays in mission delivery. The Trustees, listed in previous years as officers, are now an Advisory board that give guidance to the high level direction of the organization.
