Provided Free counseling to individuals who suffered from substance abuse and could not afford counseling. Our program became known as DASAP or Delta Junction Alcohol Substance Abuse Program funded under the Department of Behavioral Health's, Community Initiatives Matching Grant (CIMG). This grant required the use of a Logic Model, and online grant management program offered by DBH.
