On October 26, 2009 Concordia Lutheran Ministries of Pittsburgh purchased the facility now known as Concordia of the South Hills out of bankruptcy and began the process of reinvigorating the premises By the end of the current fiscal year, the company had made nearly four million dollars in improvements to the facility including a new therapy center and a new call bell system that benefits the entire community Prior to the acquisition, the prior entity had not had any new independent living residents join the community for nearly two years Since Concordia's acquisition less than five years ago, the building has filled its 126 apartment capacity The Caring Fund that was initially established by a gift of \$1,000,000 from Concordia Lutheran Ministries has been utilized in conjunction with general charitable care by the organization to provide benevolent care during this fiscal year The company has also opened itself to the surrounding community by allowing local groups to utilize the meeting rooms at no cost and faith based services performed at the facility are open to the public

The skilled nursing facility at Concordia of the South Hills is licensed for 46 beds and provides care to individuals in need of long term care or short term rehabilitation Since the acquisition, the skilled nursing area of the facility has been completely remodeled The remodeling included new carpet, wall coverings, resident furniture, and televisions The state of the art therapy center that was completed in the previous fiscal year allows residents to receive therapeutic care on the same level of the facility that they reside for their nursing care The organization has also implemented a new electronic medical records system that allows for better tracking and accessibility of patient information to better meet their individual needs while they are in our care Multiple patients who have exhausted their financial resources have been subsidized to ensure that they may remain in the facility Concordia employees have also participated in health fairs and other informative services in the surrounding communities

The personal care facility at Concordia of the South Hills is licensed for 58 personal care units and 12 memory support units Multiple patients who have exhausted their financial resources have been subsidized to ensure that they may remain in the facility Concordia Lutheran Ministries of Pittsburgh also purchased four bankrupt stand alone personal care facilities in the surrounding area of Pittsburgh The facilities now operate as Concordia of Cranberry, Concordia of Fox Chapel, Concordia of Franklin Park, and Concordia of Wexford The facilities are licensed for 84, 61, 100, and 56 beds respectively Those residents in our care receive assistance with daily activities, three chef-inspired meals every day, regular housekeeping and laundry services, an abundance of engaging activities Concordia Lutheran Ministries also established the Benevolent Care Fund with a gift of \$500,000 to help provide charitable care to the residents of these facilities Through the use of the Caring Fund and Benevolent Care Fund in conjunction with general charitable care by the organization, Concordia Lutheran Ministries of Pittsburgh provided over eight hundred and fifty thousand dollars in benevolent care during this fiscal year alone The individual organizations have also sponsored Rotary Clubs and various sports teams in their local markets such as the Shaler Thunder Baseball, as well as supported local fire departments with donations such as the Mount Lebanon Volunteer Fire Department and the Franklin Park Volunteer Fire Department
