Anna Julia Cooper Episcopal School now serves 66 students in the 6th, 7th and 8th grades. The school day begins with prayer, breakfast and announcements. Core classes consist of Math, Science, History and English. Hot lunch is served at midday and the afternoons consist of more classes, then Physical Education four days a week. Every Wednesday at midday there is a chapel service. There is also an extended day program that offers art, theater, mentoring and outdoor adventure. The required summer program offers Math and English enrichment classes, basketball, art, cooking, games and music.

4b (Code:) (Expenses \$ 5,355 including grants of \$) (Revenue \$)

Emergency Services- from time to time the school will provide emergency assistance to one of the families in need. Rent, utilities, and gasoline were provided to approximately 15 families during the school year.

4c (Code:) (Expenses \$ 111,600 including grants of \$) (Revenue \$)

Scholarships- The Anna Julia Cooper Scholarship Foundation was established in 2013 to provide scholarships for students of limited resources, primarily from Richmond's East End, to attend Anna Julia Cooper Episcopal School, St. Andrew's School, Trinity Episcopal School, and other independent schools in Richmond, Virginia. Individuals and businesses who contribute to the Scholarship Fund and pay taxes in the Commonwealth of Virginia are eligible to receive a 65% state tax credit as part of the Education Improvement Scholarships Tax Credit program. During the 2013-2014 school year, 95 students received scholarships.
