Form 990, Part I, Line 6: Although the Network successfully encouraged thousands of individuals to take action in support of its causes by contacting their representatives, speaking with others about our issues, writing op-eds, or taking other action in favor of the Network's policy positions, such individuals were generally expressing their own views and not acting on behalf of the Network. Accordingly, we have not counted the citizens we mobilized as Network volunteers. The volunteers reported here are our board members, who serve without compensation.

Form 990, Part III, Line 3: During the tax year, American Action Network wound down its Hispanic Leadership Network and did not conduct any public policy awareness events or policy panels in connection with that program. Any social media, digital or other outreach to interested Americans as part of that program was minimal, and any ongoing outreach to HLN members has been merged into the Network's general legislative issue advocacy program. Also during the tax year, the Network's National Grassroots Network program shifted exclusively to online engagement with network participants, wound up all existing leases of office space, and was merged into the American Action Network's general issue advocacy program in line 4a.

Form 990, Part III, Line 4: Program services reported in this section do not include expenses for political campaign intervention or other activities of the Network that do not directly further its purposes according to current IRS guidance. In contrast, some such expenses are reported as "program service" expenditures rather than management or fundraising expenditures in Part IX, given the slightly broader definition of program service there.
