

Ethiopia, "Transformation Love - Ethiopia". We provide the children with clothing, education support, and food and health care for their family
We also on occasion help with rent payments. We are working to train the mothers in business through our Income Generating initiative.
In fiscal 2013 we sent \$112,205 to Ethiopia for the purpose of running the child sponsorship ministry and to help with the above mentioned.

Part 1 Line 16: Travel expenses for our board members to make ministry-business trips to Ethiopia accounted for \$6,677 in expense for 2013.
We also had expenses for purchasing supplies and gifts for sponsored children to use in the ministry and to bring to Ethiopia with us in the
amount of \$3,088 during fiscal 2013.
