

Line 8, Other Revenue: \$ 1,932 represents reimbursements from Fairview High School items we paid last year, including grant money from the school's parent organization for auditorium equipment, a choir banquet, a sound engineer for a concert, and other minor reimbursements.

Line 10, Grants and similar amounts paid: \$ 49,749 went to Fairview High School in Boulder, CO. This included grants to pay two department assistants and a choir director (\$ 21,750), music purchase (\$ 14,644), professional development (\$ 2,313), wardrobe expenses (\$ 1,675), honoraria for department assistance (\$ 1,203), equipment maintenance (\$ 1,486), general supplies for the choir department (\$ 798), scholarships (\$ 2,816), professional clinics for students (\$ 2,890), and other minor items. Total = \$ 49,749.

Line 16, Other expenses: \$ 83 is made up of bank fees (\$ 29), office supplies (\$ 42) and organization report filing with the state of Colorado (\$ 10), and a misc expense (\$ 2).

Line 26, Total Liabilities: \$ 7,753 is made up of professional service expenses, such as concert recording, sound tech and printing (\$ 5,821), ticket sales supplies (\$ 603), wardrobe purchase and cleaning fees (\$ 1,068) and other minor items (\$ 261). Total = \$ 7,753.
