




Teachers benefited from professional development sessions and classroom visits from science and music professionals, which helped the teachers integrate science and the arts into their classroom instruction. Teachers and students also benefited from several field trips to several local educational and cultural institutions.

The compensation of the organization's current President, who succeeded the first President and CEO on October 31, 2012 is considerably lower than that paid to the first President and CEO. To determine the reasonableness of the compensation for the General Counsel and COO, the President and CEO consulted the most recent compensation survey published by the Michigan Nonprofit Association. She then presented the finding and compensation recommendations to the organization's Compensation Committee which approved the recommended compensation. The compensation of the General Counsel and COO has not increased since it was initially approved by the Compensation Committee.
