The Children's Hospital ("TCH") is an IRC Sec 501(c)(3) tax-exempt organization whose sole purpose is to provide charitable financial support to charitable organizations in Hamilton County, Ohio that participate in the treatment and/or research of diseases or disorders affecting children Such charitable financial support is provided primarily through expendable income generated by investments of endowment and other funds received by TCH It is the policy of TCH to invest gifts and bequests received and to reinvest funds obtained from the sales of investments in order to enhance future expendable income During the tax year July 1, 2013 to June 30, 2014, in fulfillment of this charitable mission, TCH provided financial support amounting to \$49,859,839 to Cincinnati Children's Hospital Medical Center ("CCHMC") to support its charitable efforts in pediatric patient care and related research Effective December 31, 2012, The Children's Hospital Foundation, Cincinnati, Ohio, a not-for-profit Ohio corporation organized for the purpose of acquiring and investing contributions, engaging in fund-raising activities and managing its assets in order to benefit CCHMC, merged into TCH and is no longer in existence
