Individual Development Accounts (IDAs) are matched savings accounts that enable low-income American families to save, build assets, and enter the financial mainstream IDAs reward the monthly savings of working, poor families who are building towards purchasing an asset, most commonly buying their first home, paying for post-secondary education, or starting a small business ECDI currently offers grant dollars matched to an individual's personal savings for those who wish to start a small business, and have household earned income at or below 200% of the Federal Poverty Guidelines

The ECDI Small Business Loan Program provides loans in amounts up to \$350,000 to small businesses in several communities located in Ohio Under this program, ECDI is able to make loans to low and moderate-income entrepreneurs, or those with insufficient credit histories to qualify for a loan through a traditional financial institution Rates and terms depend on the risk, size, and profitability of the business, as well as the needs of the borrower, however these interest rates are fixed In addition to traditional, fixed-rate loan products, interest-free, fee-based loans are available for borrowers whose religious beliefs preclude them from paying interest

ECDI has extensive training and technical assistance available to help its clients acquire the knowledge and tools they need to succeed All programs begin with foundational Financial Literacy training, which teaches personal financial management skills ECDI also provides general business development training courses, during which entrepreneurs are given the tools they need to start and successfully manage a business In addition to financial literacy and general training, ECDI offers business development training geared towards specific industries such as food-based or home-based childcare businesses and ongoing topical seminars that address topics relevant to entrepreneurs If a client needs additional help, ECDI's staff is trained to address individual issues with the entrepreneur one-on-one
