Safe Housing Program (SHP)-Community Alliance of Tenants (CAT) organizers and volunteers have organized 7 (305 households reached) buildings in Portland and Beaverton that were experiencing severe disrepair. Renters were experiencing issues ranging from no heat, mold, broken locks, mice, roaches, broken kitchen appliances, and interior water damage. They have been working with groups that are historically under represented; refugee communities that speak Nepali, Burmese, Zomi and Karen. Tenants worked together to write collective letters, learn about their rights and responsibilities, connected with HomeForward, and over 70 households participated in rallies and public speaking events sharing their experiences.

4b (Code:) (Expenses \$ 131,294 including grants of \$) (Revenue \$)

Education Program (EP)-The Renters' Rights Hotline reduced call turnaround time to same day or within 24-48 hours, getting much needed information to callers in crisis very quickly. The EP also is responsible for educational outreach in the community, giving renters rights presentations to at risk renters who benefit greatly from understanding their rights and responsibilities as renters. So in 2013 CAT through the EP has given 16 community presentations and educational information to over 350 renters in Portland, East Portland and Washington County. Additionally, we have given 3 landlord/tenant law trainings to volunteers so that they have the ability to answer calls on the hotline. Trained over 58 English and/or Spanish speaking volunteers on the hotline. We counseled over 2800 callers throughout the state of Oregon on how to best self-advocate for their rights. The highest call trends were eviction, repairs, and non payment of rent.

Housing Justice Program (HJ)-In collaboration with JOIN, StreetRoots, 211info and Oregon Opportunity Network, CAT relaunched the hugely successful "We are the PDX Safety Net" social media campaign, ultimately securing \$4.7 million in general funds from the City of Portland for housing and homeless services and ensuring ongoing funding for the future, and securing nearly \$2 million for the Neighborhood Inspections Program. CAT is a member of the statewide Housing Alliance. 2013 was a year to organize for Housing Opportunity Agenda. In collaboration with the Housing Alliance, CAT successfully passed a state-wide bill to reform Section 8 so that voucher holders have more choice in the market. Tenants can no longer be denied housing solely for having a section 8 voucher. CAT participates in the Oregon Landlord-Tenant Coalition. CAT successfully negotiated with landlords to: reduce barriers for tenants during the screening process; limit how landlords can require tenants to purchase renters insurance and; add additional protections around how landlords can charge fees.
