Working in 3 regions of Haiti--Grand Colline in central Haiti, Acul de Nord in Northern Haiti, and Fonds Verrettes along the Haitian/Dominican border--Plant With Purpose provided education in sustainable agriculture, agroforestry, reforestation, microfinance, discipleship, and marketing assistance to 3683 members in 89 communities Families partnering with Plant With Purpose planted 278,809 trees, conserved 118 miles of soil through erosion-control barners, and established 150 agroforestry farms plots These sustainable farming techniques ultimately mean families are growing more food 87 VSLAs (Village Savings and Loan Associations) with 2,027 members were established, ending the year with a total member equity of \$124,371 USD 245 water purification systems were distributed among participating families and communities Plant With Purpose partnering families are sending their daughters to school at a rate of 20 percent higher than nonparticipating families This means 228 girls attend school who would not otherwise be able to go PARTICIPANT TESTIMONY ***Guillaume Laurent shares, "I realized many activities like reforestation and rock barriers to protect my farms, so that I could have a better yield to take care of my children " ***Loziana Tout Puissant says, "Compost helps me to stay healthy because it is natural, without chemicals When more food grew from my farm, I sold and ate some Automatically, my economic situation improved "

DOMINICAN REPUBLIC Working in the central region of the Dominican Republic and along the Haitian/Dominican border, Plant With Purpose has provided training, marketing services, and microenterprise to 2,488 families in 61 communities The government of the Dominican Republic turned to Plant With Purpose for collaboration on a national literacy campaign This work is being done in partnership with our church mobilization program Churches and VSLA groups are now the platform for local adult literacy groups, establishing 40 groups in 2014 81 VSLAs with 1,844 members and total member equity of \$281,752 USD, 216 new Bible study groups established in partnership with 50 local churches 501,877 trees planted ***PARTICIPANT TESTIMONY In the Dominican Republic, Plant With Purpose is creating a culture of saving as 100 percent of partnering households are active VSLA members (2014 Impact Evaluation) In 2011, five percent of participating households had enough emergency cash reserves for six months That has grown to 18 2 percent (2014 Impact Evaluation) Alejandro Castillo Jimenez in Loma Verde is experiencing the freedom that comes from saving "Economically, the implementation of savings groups (VSLAs) has been a blessing because we have learned to save and we get our loans cheaper compared to lenders With loans from the group, I'm building a house I have also invested in my pottery business and in selling fish Through these activities I can generate enough income to meet basic needs for food, health, and education for my family "

TANZANIA Worked with 5,552 families in 64 communities in the Kilimanjaro region of Tanzania Motivated by a group competition, savings-and-loan groups planted 1,193,184 trees in their communities and mobilized churches and schools to participate alongside them Participating households planted on average 413 trees, according to the 2014 Impact Evaluation Impact Evaluations from 2011 shared that partnering farmers planted 39 trees a year This increase can be credited to the annual tree planting competition that started in the winter of 2012 The 2014 tree planting competition commenced with an organic agriculture festival with more than three thousand people in attendance Farmers from the Kilimanjaro region brought their organic produce, and the rich display of local produce opened conversations about the importance of organic agriculture and sustainable farming The Regional Commissioner of Kilimanjaro, who hosted the awards ceremony, expressed shock at the event turnout When asked how it was possible to organize such a large group, Plant With Purpose Tanzania staff pointed to the VSLA groups' commitment to community transformation "The desire to heal the land and its people is the main motivating factor of this gathering " Overall, partnering families in Tanzania have planted 4 3 million trees These trees are healing the land, increasing crop production, and restoring water sources Other stats 75 new VSLA groups with 5,552 members and total member equity of \$583,981 USD, 22 new church partnerships and engaged an additional 61 institutions in "Redemptive Agriculture" trainings, 1,220 households with "double dug" family gardens ***PARTICIPANT TESTIMONY Shira Isambi from Marangu-Mwika, Tanzania shares, "My relationship with God is growing every day because I can see day to day blessings as I keep on working hard while calling for His support I see positive response "

MEXICO The program in Mexico spans the states of Oaxaca and Chiapas In FY2014, Plant With Purpose Mexico worked with 1,309 families in 76 communities Other Stats 41 VSLAs with 518 members and total member equity of \$55,580 USD, 31 sophisticated wood-saving stoves built, 41 large-tank cisterns constructed, 122 chicken coop projects completed on family farms, 108 Festival of Values, Stewardship of Creation, and Self Esteem workshops held at partnering churches Volunteer promoters assist the Plant With Purpose staff by helping partnering communities build much-needed health and sanitation projects such as water cisterns, fuel-efficient stoves, and latrines Each of these improved technologies restore the environment and the community’s health Plant With Purpose Mexico has equipped communities and families to construct 221 large-capacity cisterns, 385 highly effective wood-saving stoves, and 557 ecological latrines Plant With Purpose staff member Jorge shares, "We are planning to attack the problem [of water shortage] from the root Otherwise, there will be drought problems over and over again It's a long-term project and will take years The focus is on the future " To further improve their land, partnering farmers are adopting a higher number of sustainable farming techniques than nonparticipating households Compost, cover crops, and integrating trees with crops all contribute to improved soil quality and crop production According to the 2014 Impact Evaluation, partnering households have 70 percent greater crop diversity than nonparticipants This means better nutrition for families and greater biodiversity to aid in watershed health PARTICIPANT TESTIMONIES ***Eleazar Pacheco Hernández from Monte Flor shares, "The garden has helped our nutrition, we are eating more vegetables now, whereas before we didn't eat any We also have meat and eggs to eat thanks to our chickens " ***Martha Garcia Contretras shares, "There is greater reconciliation among community members The values that [Plant With Purpose] has instilled in our kids are unlike anything they're learning at school They are seeing things in new ways The participation of the community is incredible to see " Churches are leading the way in Creation Care projects including community recycling programs

BURUNDI, AFRICA Plant With Purpose is currently working with 4,837 members in 47 communities In Burundi, 73 4% of the population is undernourished-the highest rate of hunger in the world (World Food Programme, 2012) Impact Evaluations showed that participating farmers are planting more diverse gardens with a total of 32 different crop species Greater crop diversity means resistance to risk (pest, drought, growing conditions) and harvests throughout the year This increases the opportunity for income generation OTHER STATS 221 VSLAs with 4,837 members and total member equity of \$124,028 USD, 314 Farmer Field School participants learned sustainable farming techniques, 225 church leaders gained leadership development and theological training through the "Theology of Work" program, 19 fulltime national staff members with 44 part-time support staff, 8,000 trees planted in one day at the Nyakazu Watershed restoration kickoff event PARTICIPANT TESTIMONY ***Elise Kaganda from Kiremba shares, "With the help of Plant With Purpose Burundi, we hope that gradually we can achieve this "dream" of developing our agricultural activities to meet our food needs and at the same time give us income " ***Intensified focus on planting trees is also bringing about food security Claudette Niyonzima shares, "Our region is seriously threatened by drought and this is largely due to the lack of tree planting Personally, I have planted over 100 agroforestry trees and 30 fruit trees " Claudette lives in Muzye at the lower edge of the Nyakazu Watershed A baseline study of the Nyakazu Watershed was conducted to understand existing needs and current biodiversity Trees planted in this area are anchoring soil, increasing water quality, and creating economic opportunities ***Within this last year, the number of Village Savings and Loan Associations grew from 51 groups to 221 92 percent of participating households are actively saving cash through VSLAs to meet practical needs like purchasing food, paying school fees, and covering the cost of medical care For the first time in her life, Maria Hanabunara says, "I was able to pay off all my debts!" and her children are now all in school

THAILAND Plant With Purpose worked with 1,731 families in 25 communities in Northern Thailand OTHER STATS 7 VSLAs with 156 members and total member equity of \$6,832 USD, 17 churches participated in training programs, impacting 2,825 people, 1,649 marginalized hill tribe citizenship cases resolved, 381 family farms established to improve nutrition In a country where less than one percent of the population is Christian, Plant With Purpose is building local church capacity to engage with their communities This year, Plant With Purpose trained more than 130 pastors and church leaders on the Biblical call to care for the environment A network of 97 churches is committed to Creation Care and engaging their youth in environmental care activities The Green Church Project-a collaboration with Compassion and Operation Blessing Foundation-was developed to promote sustainable and organic farming practices Country Director Bunsak Thongoi published a handbook on agroforestry that focuses on a Christian approach to Creation Care Partnering families are twice as likely to recognize their churches' involvement in creation care projects PARTICIPANT TESTIMONY Participating households are protecting significantly more land than comparison households (2 13 acres versus 0 71 acres) This means that the 1,731 partnering farmers are protecting over 2,000 acres of land by planting trees, composting, and soil conservation barriers Farmers like Mr Promma JongKham realize the significance of taking care of their farms "I think if more people do as we have been taught, not to burn the fields but use soil conservation, it will help our village environment "
