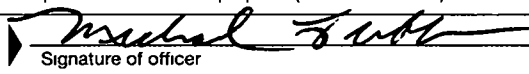

The Irvine Community Alliance Fund has historically been more than 33 1/3% publicly supported throughout its existence. In 2009 and 2013, the fund received extraordinary donations from trust proceeds (\$100,000 in 2009 and \$139,270 in 2013), which reduced the level of public support over the five-year period from 61% to 26% in the current reporting year. It is an anomaly and does not represent the typical support profile for this fund.
