San Diego Public Library Foundation (the "Library Foundation") is a California Nonprofit Corporation established in 2002 The Library Foundation strengthens communities by supporting excellence in the San Diego Public Library system through philanthropy, advocacy and outreach The Library Foundation will create a community where all people are engaged, literate and empowered to fully participate in society We accomplish this vision by partnering with the San Diego Public Library to develop the world’s best library system The Library Foundation raises funds and provides a wide range of resources to meet ongoing needs at all 36 libraries throughout the City of San Diego including books, capital for new libraries, programs, equipment, technology and online resources To date, the Library Foundation has provided more than \$100,000,000 in funding to the San Diego Public Library system The net assets of the Library Foundation will fluctuate significantly from year to year primarily as a result of funding capital for new library facilities in the San Diego Public Library system, for instance, net assets at June 30, 2014 were approximately \$4.7 million less than at June 30, 2013 as the Foundation pays down capital expenditures Through donor support, the Library Foundation deepens the Library’s role as a center of learning, creativity and innovation in the digital age Library Foundation donors help minds grow and enhance the Library’s proven track record for strengthening communities throughout San Diego
