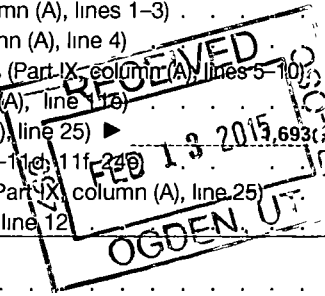

Clean Water. The program's goal is to meet water quality needs of natural and human communities within a defined geography. The Partnership's standards and verification processes have facilitated investments in over 4 miles of stream restoration in the Rogue, Willamette, and Lewis and Clark Rivers. In collaboration with state and federal agencies, the organization also released a draft set of regional recommendations on how to build water quality trading programs.

Resilient Habitats: This program creates networks of habitat sufficient to support native species and ecosystem function over time. In Oregon's Willamette Valley, the Partnership has been working with five vineyard owners to develop and fund plans to conserve and restore native prairie as part of the new Salmon Safe+ program. As a result of new policy and technical tools developed by the Partnership, the first 140 acres of new prairie conservation area are in the final stages of acquisition in Thurston County, Washington
