At The Wilderness Center (TWC), we offer school, group, family and adult workshops, courses, ecotours and walks throughout all seasons. During our fiscal year ended June 30, 2014, TWC's youth and adult programs served approximately 10,900 people of all ages. During our current fiscal year, a total of 7,372 students from local schools participated in TWC classes.

4b (Code:) (Expenses \$ 312,325 including grants of \$) (Revenue \$)

The Wilderness Center's facilities include an Interpretive Building containing classrooms, meeting rooms, exhibits, a wildlife observation room and a bookstore/gift shop. TWC's Astronomy Education Building houses an observatory and the Fred F. Silk Planetarium. TWC also offers 10 miles of hiking trails, 3 picnic shelters and an observation tower for the public's enjoyment and enrichment. During our fiscal year ended June 30, 2014, more than 76,905 visits were made to our Interpretive Building and thousands of individuals made use of TWC's other facilities.

The Wilderness Center's land protection and conservation programs continued to grow during our fiscal year ended June 30, 2014. TWC currently protects more than 3,600 acres of forest, prairie and farmland and more than 13 miles of streams throughout a seven-county area. The Center currently owns (in fee) 2,096 acres, and holds the deed to an additional 63 acre wetland that was purchased with the revolving land fund. TWC is holding this land while the Holmes County Park District applies for grants to purchase the land from the Center. TWC holds conservation easements on 1,195 acres. TWC Consulting Forestry currently maintains management plans for more than 14,000 acres. TWC is now introducing a new program known as the Community Watershed Conservation Partnership (CWCP). This program will provide land owners with a way to protect, enhance or restore wildlife habitat on their property through the use of a non-binding agreement.
