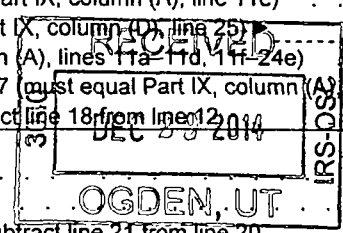

The Ignatian Solidarity Network (ISN) is a national social justice organization inspired by the spirituality of St. Ignatius of Loyola. ISN was founded in 2004 and is a lay-led 501(c)(3) organization working in partnership with Jesuit universities, high schools, and parishes, along with many other Catholic institutions and social justice partners.

The Ignatian Family Teach-In for Justice brought together over 1,300 people affiliated with Jesuit and partner universities, high schools, parishes, and other ministries for a 3-day conference. The Teach-In is now the largest annual Catholic social justice conference in the U.S. and includes inspiring speakers on various human rights and environmental justice topics including climate change, migration, refugees, worker rights, etc. The Teach-In also included the opportunity for students to learn about the legislative process and participate in an advocacy on Capitol Hill where they could develop their skills while discussing justice-issue topics with Congressional staffers and members. Leader Development: ISN hosted two leadership summits for high school students and faculty. Named after the late Pedro Arrupe, S.J, former leader of the Jesuits internationally, the Arrupe Summits offer students and teachers the opportunity to explore the relationship between service, social justice, faith, and leadership. In total, nearly 100 students from Jesuit high schools across the U.S. participated in the two summits held in California and Ohio. ISN welcomed faculty and staff from over 30 Jesuit and partner Catholic institutions to a training summit on the integration of issues of race, culture and privilege into domestic and international immersion experience programming. In partnership with Training for Change, ISN created the program to offer tangible methods that faculty and staff could utilize to engage their students and colleagues on these important elements of culture that relate to social justice and human rights issues encountered during immersion experiences. The Ignatian Solidarity Network continues to grow its available content for students, parish members, faculty, staff and others related to faith and social justice at http://www.ignatiansolidarity.net/. In 2013-2014 ISN saw a 200% growth in unique visits. In addition, significant growth occurred in engagement via social media, with similar growth to Facebook and Twitter networks over the course of the year.
