During the current fiscal year, the Foundation has helped to fund 16 lectureships, 21 fellowships, 12 academic chairs, 7 professorships, over 65 University of Akron colleges and departments, 2 pre-college programs, the University Press, 12 internships, 4 centers, the History of Psychology archive, and 5 institutes at The University of Akron.

One of the Foundation's objectives is to assist The University of Akron with funding for student financial aid. In fiscal 2013-2014, the Foundation provided funding for over 473 scholarships, grants and loans housed within The University of Akron.

The University of Akron Foundation supports The University of Akron's campus enhancement program by helping to fund physical improvements.
