 THE EDUCATION FOUNDATIONS ANNUAL PROGRAMING GRANTS HAVE PROVIDED \$321,300 TO-DATE FOR 278 TEACHER GRANTS SINCE 1995 THAT HAVE IMPACTED 24,000 STUDENTS. THE FOUNDATION FUNDS \$22,000 ANNUALLY, FOR INNOVATIVE CLASSROOM AND PROFESSIONAL DEVELOPMENT GRANTS, THROUGH THE COMPETITIVE TEACHER AND PRINCIPAL GRANT PROGRAM PROCESS.

THE NEW PRINCIPAL GRANT PROGRAM HAS AWARDED THREE GRANTS TOTALING \$3,225. TEACHERS AND PRINCIPALS SUBMIT COMPLETED GRANT APPLICATIONS BY THE ANNUAL SPRING DEADLINE. UPON SELECTION BY THE TEACHER GRANT/PROGRAM COMMITTEE, RECIPIENTS ARE REQUIRED TO SIGN THE EDUCATION FOUNDATION GRANT AGREEMENT WHICH STATES THAT THEY AGREE TO USE THE GRANT AS SUBMITTED, AND COMPLETE THE FINAL GRANT REPORT, (SEE SCHEDULE O)
