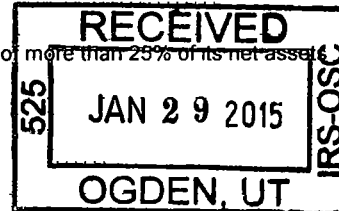

Through the development of a statewide organization, IndianaFIRST will make Indiana a STEM program leader.**

**Over the past three years, TPF4Y has worked to leverage resources, grow awareness, and build capacity for robotics programming across the state. By 2015, IndianaFIRST, with the help of TPF4Y, will ensure 50% of**

**The US2020 organization emerged from a White House call to generate solutions to our STEM education and workforce challenge with a goal to deploy 1 million STEM professionals as mentors, volunteers, or coaches into the community by the year 2020. Us2020 created a national competition for cities to submit applications to be named a leader in this movement, 7 cities were selected as winners, sharing nearly \$1 million in resources from US2020. The City of Indianapolis is one of those cities, and TechPoint Foundation is leading the US2020 initiative for Indianapolis. This initiative is focused on serving girls, low-income youth, and students of color (groups typically underrepresented in STEM fields).**
