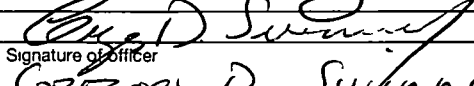

After serving in campus ministry for 26 years, the Executive Director, Greg Swinney, started Crossroads to focus solely on ministry

to international students. The growth trend of internationals in college in the US showed a steep upward path increasing

exponentially with no sign of stopping. Many of the One million plus internationals - reportedly near 66% - left the US after two or more years

in college having never been inside an American home. For this reason, Crossroads started as a resource for campus ministers across the country to get training and materials in starting or building international student outreach. Attending conventions with thousands in attendance (i.e. the North American Christian Convention and the International Conference on Missions) annually, there were opportunities to present workshops, host exhibit booths, and otherwise get exposure that help is available through the Crossroads ministry.

"The second largest program for Crossroads International Student Ministries in 2014 is Training Resources and related Travel Expenses.

Of the approximate \$75,000 expense budget, approx 8% went towards training ministries across the United States on how to start international student ministries on college campuses. With over one million international students attending college in the United States in 2014, Christian campus ministers saw the need to reach out to these students so far from home and family and demonstrate the love as taught by Jesus Christ. Numerous campus ministers contacted the Crossroads Executive Director requesting him to come to their campus for a period of days to help them train their staff and start a committed ministry to international students and visiting scholars. This includes training on cultural differences, starting ""Conversation Table"" groups to meet the needs of international students wanting to improve their English conversation skills, hosting events for fellowship and Bible teaching, and finding Friendship Families to connect with students to experience American culture in a family environment (not a home stay program but a friendship building program).

The third largest program expenditure (about 4% of total spent for the year) for Crossroads International Student Ministries in 2014 was for resource materials provided free of charge to churches and campus ministries across the United States.
